Packed in paper sack, plastic, raffia and aluminium containers, big-bags, bags in cardboard boxes and plastic and metal jars. Production (blending and filtering) and packing of sweet and spicy Capsicum oleoresins in plastic jars. Packing Food colouring in jars and plastic bags. Production (mixing) and packing of vanilla sugar in paper sacks, plastic sacks, plastic bags, aluminium bags and plastic jars. Outsourced processes of ETO treatment, smoking, grinding and blending.
